The Hudson River Park Trust (the “Trust”) is pleased to invite qualified landscape architect led teams to submit proposals in response to this RFP for Design and Related Consultant Services for W. 29th to W. 46th Street Landscape and Esplanade located in Hudson River Park. The team shall provide comprehensive planning, design and phased construction document packages, and construction administration services, as further detailed in the RFP. Disciplines and specific services needed include but are not limited to: (a) Traffic and Transportation Planning and Engineering; (b) Civil, Structural, M/E/P, Geotechnical, Environmental, and Marine Engineering; (d) Ecological, Lighting, Irrigation, and Wayfinding Design; and (e) Cost Estimating, Expediting, and Specification Writing. The team shall be experienced in managing complex multidisciplinary projects with budgets in excess of \$50 million.
