Newly improved with water features and areas for large and small dogs. Located at W 23 St. in Chelsea Waterside Park.



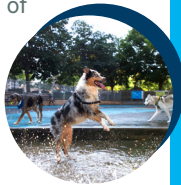
Gansevoort Peninsula Dog Park

Hudson River Park loves dogs. We've built parks for them and you! Remember to be safe, obey the rules and respect the Park and others.

Rules & Regulations

- › Dogs must be on a leash (no more than six feet long) at all times, except in designated dog areas.
- › New York State Law: All dogs must have a NYC license tag and valid rabies tag.
- › Keep dogs off the grass and out of planted areas.
- › You must pick up after your dog — including brushed dog hair — and dispose of the waste in containers provided throughout the Park, not in compost bins.
- › Dogs must always be under the control of their owner.
- › Dogs are not permitted in playgrounds, on turf fields, or on basketball, pickleball and tennis courts.

Did you know...

the harmful effects of urine?

Dog urine is high in salt which kills grass and plants, undermining our efforts to keep the Park looking its best.

the problem with poop?

Dog poop is not a fertilizer. It contains *E. coli*, a harmful bacteria to humans, pets and water quality. Separating dog areas helps keep adults and children who lounge and play on the grass safe.

Our hard-working gardeners tend the lawns and plant beds year-round. It's unpleasant and discouraging for them to encounter dog poop on the grass or among the flowers. Respect Park workers and other patrons by picking up after your dog.

the danger of off leash?

Hudson River Park is narrow with an extremely busy bikeway and the West Side Highway on one side and the Hudson River, with its dangerous currents, on the other. Protect your dog and others, wildlife and Park patrons by using a leash while outside of the dog parks.
